Dear Judge Wood:

Governor Perry has asked me to inform you that he has received notice from the U.S. Secretary of Agriculture that your county has been designated eligible to apply for low-interest emergency disaster loans due to drought that occurred from May 1, 2010 through December 31, 2010.

The Secretary has notified the Administrator of the Farm Service Agency (FSA) to immediately make emergency loans available to eligible applicants in your county. Your local FSA office will have the details on this program.

In addition, the Small Business Administration (SBA), in an agreement with the U.S. Department of Agriculture (USDA), provides Economic Injury Disaster Loans to eligible small businesses dependent on farmers and ranchers in counties that have received a disaster declaration from the Secretary of Agriculture.
