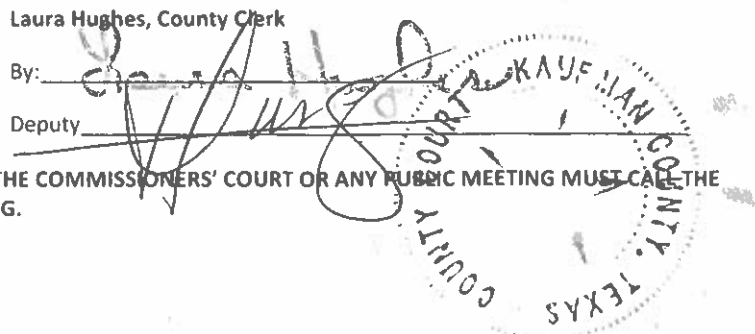

KAUFMAN CO. CONST. PCT. 1 has adopted a detailed written policy on racial profiling. Our policy:

- 1) clearly defines acts constituting racial profiling;
- 2) strictly prohibits peace officers employed by the KAUFMAN CO. CONST. PCT. 1 from engaging in racial profiling;
- 3) implements a process by which an individual may file a complaint with the KAUFMAN CO. CONST. PCT. 1 if the individual believes that a peace officer employed by the KAUFMAN CO. CONST. PCT. 1 has engaged in racial profiling with respect to the individual;
- 4) provides public education relating to the agency's complaint process;
- 5) requires appropriate corrective action to be taken against a peace officer employed by the KAUFMAN CO. CONST. PCT. 1 who, after an investigation, is shown to have engaged in racial profiling in violation of the KAUFMAN CO. CONST. PCT. 1 policy;
- 6) requires collection of information relating to motor vehicle stops in which a warning or citation is issued and to arrests made as a result of those stops, including information relating to:
  - a. the race or ethnicity of the individual detained;
  - b. whether a search was conducted and, if so, whether the individual detained consented to the search;
  - c. whether the peace officer knew the race or ethnicity of the individual detained before detaining that individual;
  - d. whether the peace officer used physical force that resulted in bodily injury during the stop;
  - e. the location of the stop;
  - f. the reason for the stop.
- 7) requires the chief administrator of the agency, regardless of whether the administrator is elected, employed, or appointed, to submit an annual report of the information collected under Subdivision (6) to:
  - a. the Commission on Law Enforcement; and
  - b. the governing body of each county or municipality served by the agency, if the agency is an agency of a county, municipality, or other political subdivision of the state.

The KAUFMAN CO. CONST. PCT. 1 has satisfied the statutory data audit requirements as prescribed in Article 2.133(c), Code of Criminal Procedure during the reporting period.

**Writ of Possession Plaintiff (Landowner/Homeowner) Responsibilities-**

- \*The Plaintiff is responsible for having enough people to help move remaining household items and furniture out of the residence during the Writ.
- \*The Plaintiff is responsible for changing out all the accessible exterior locks in the presence of a Deputy Constable. Also, all exterior windows and doors need to be locked and secured.
- \*The Plaintiff is responsible for having helpers physically remove remaining items out of the residence and on to a grassy area on the property. Items are prohibited from being placed on a sidewalk or roadway. The Plaintiff is recommended to leave the items out on the grass for a minimum of 24 hours from the start time of the Writ to allow the tenants access and time to grab items.
- \*The Plaintiff is responsible for calling a bonded towing company prior to the Writ to schedule the removal of any immobile vehicles, or trailers that remain on the property.
- \*The Plaintiff is prohibited from trashing any items during the Writ. All items remaining in the house are required to be placed on the designated grassy area.
- \*If the Writ exceeds <sup>2</sup> hours after the start time, the Plaintiff will be charged/billed at a rate of <sup>50</sup> \$40/hour per Deputy Constable on scene. Please refer to the Comal County website for the posted Constable fee schedule.
- \*If it begins to actively rain, sleet, or snow at any time during the Writ, it is mandatory for any activity to stop immediately until the rain, sleet or snow has completely stopped.
- \*The Plaintiff **should not** enter the residence at any time before the scheduled Writ of Possession and should wait until Deputy Constables have arrived to confirm the residence is safe to enter to begin the eviction process. If the Plaintiff decides to enter the residence before Deputies arrive, the civil process has been compromised, in which could result in the Writ of Possession being ultimately canceled.

**We hope these reference points will help to better explain what is needed to happen in order to successfully and efficiently execute a Writ of Possession. We understand this process may be overwhelming, but we are here to help explain the process.**

- 3) implements a process by which an individual may file a complaint with the KAUFMAN CO. CONST. PCT. 4 if the individual believes that a peace officer employed by the KAUFMAN CO. CONST. PCT. 4 has engaged in racial profiling with respect to the individual;
- 4) provides public education relating to the agency's complaint process;
- 5) requires appropriate corrective action to be taken against a peace officer employed by the KAUFMAN CO. CONST. PCT. 4 who, after an investigation, is shown to have engaged in racial profiling in violation of the KAUFMAN CO. CONST. PCT. 4 policy;
- 6) requires collection of information relating to motor vehicle stops in which a warning or citation is issued and to arrests made as a result of those stops, including information relating to:
  - a. the race or ethnicity of the individual detained;
  - b. whether a search was conducted and, if so, whether the individual detained consented to the search;
  - c. whether the peace officer knew the race or ethnicity of the individual detained before detaining that individual;
  - d. whether the peace officer used physical force that resulted in bodily injury during the stop;
  - e. the location of the stop;
  - f. the reason for the stop.
- 7) requires the chief administrator of the agency, regardless of whether the administrator is elected, employed, or appointed, to submit an annual report of the information collected under Subdivision (6) to:
  - a. the Commission on Law Enforcement; and
  - b. the governing body of each county or municipality served by the agency, if the agency is an agency of a county, municipality, or other political subdivision of the state.
