Beavers Contracting was the apparent low bidder for the repair of Lower East Fork Lateral Site 2. Review of their bid and submitted references was performed and is summarized below.

### **Review of References**

After reviewing past projects references along with past experience with the NRCS, Beavers Contracting has provided overall acceptable construction services including earthwork, conventional structural concrete, rock riprap plunge basins, rock riprap wave berms and conduit installation. They have substantial qualified experience with the previously mentioned types of work for spillways, dams, and sediment basins. Beavers Contracting previous experience with watershed flood control structures along with other structures sharing similar attributes proves they have the appropriate experience to deal with the project at hand. The references provided along with the NRCS's experience with Beavers Contracting show that Beavers Contracting has a record of completing projects in a timely manner.

### **Review of Bid Tabulation**

Review of the total bid showed to be lower than the independent government cost estimate (IGCE) of \$1,171,929.00; 28.3% lower or -\$331,443.75. The overall bid does appear to be slightly materially unbalanced relative to the IGCE. Bid items showing over/lower 50% variation from the IGCE are Clearing and Grubbing 720.0%, Structure Removal, Fence -50.0%, Structure Removal, Ex. P.S. 60.0%, Pollution Control -70.0%, Construction Survey -50.0%, Removal of Water, -60.0%, Concrete, Structural, 68.0%, Metal Work, -60.0% Contractor Quality Control, -66.7%. See the attached Math Check of Bids for a complete comparison. Beavers Contracting Bid Item for Clearing and Grubbing Bid appears to be somewhat materially imbalance to the Engineers estimate with respect to the average contracting bid cost for that item is comparable with other bidders. Being that the overall bid is under the IGCE their bid is acceptable.

### **Recommendation**

Based on the review of the references and the review of the bid costs, I recommend awarding this contract to Beavers Contracting. Beavers Contracting has completed work in timely manner on previously referenced projects and does not appear to have any issues with starting this project on time.

**WHEREAS**, as North Central Texas continues to grow and technology evolves, sustaining a fully funded Next Generation 9-1-1 network is essential to protecting lives, supporting first responders, and safeguarding the long-term well-being of communities throughout the region; and,

**WHEREAS**, the North Central Texas Emergency Communications District (NCT9-1-1) operates pursuant to Texas Health & Safety Code Chapter 772 to provide regional 9-1-1 emergency communications services for residents and visitors within its service area; and,

**WHEREAS**, the statewide wireless 9-1-1 service fee has remained at \$0.50 per device per month since its' inception 1997, nearly thirty years without adjustment, resulting in an outdated and increasingly unsustainable funding model; and,

**WHEREAS**, Emergency Communication Districts do not have authority to levy property taxes and rely solely on state-authorized service fees to fund essential emergency communications infrastructure, network operations, cybersecurity protections, and system modernization; and,

**WHEREAS**, the Texas Legislature in 2021 mandated implementation of Next Generation 9-1-1 (NG911) statewide by September 2025, requiring the transition from legacy analog systems to secure, IP-based networks capable of routing voice, text, data, and other multimedia communications; and,

**WHEREAS**, NCT9-1-1 successfully met the mandated deployment requirements for NG911 at the time such mandate was issued; however, a long-term, sustainable funding mechanism to support its ongoing operation, cybersecurity requirements, redundancy, and lifecycle replacement costs has not yet been established; and,

**WHEREAS**, underfunding the 9-1-1 system jeopardizes public safety by threatening the security, reliability, resiliency, and timeliness of emergency response services for all residents and visitors in the NCT9-1-1 service area; and,

**WHEREAS**, most states have increased their 9-1-1 fees to reflect modern operational realities, with only a small minority of states maintaining fees at \$0.50 per month or less, and many charging significantly higher amounts; and,

**WHEREAS**, a 2024 statewide survey found significant statewide support for increasing the wireless 9-1-1 fee, demonstrating broad public recognition of the importance of sustaining emergency communications services; and,

**WHEREAS**, ensuring that Texas 9-1-1 systems remain reliable, secure, modern, and capable of handling voice, text, and multimedia emergency communications is essential to protecting lives and property in all communities.

**NOW, THEREFORE, BE IT RESOLVED THAT the Commissioners Court of Kaufman County, Texas:**

**Section 1.** Expresses its support for legislative action to adjust the statewide wireless 9-1-1 service fee to a level that reflects the true cost of providing resilient, Next Generation 9-1-1 services and provides an ongoing automatic methodology for adjustment based on the Consumer Price Index (CPI).

**Section 2.** Supports establishment of a sustainable, long-term funding model to ensure continued operation, cybersecurity protection, redundancy, and modernization of Texas 9-1-1 systems.

**Section 3.** Directs that a copy of this Resolution be transmitted to the North Central Texas Emergency Communications District, the Governor of Texas, the Lieutenant Governor, the Speaker of the Texas House of Representatives, and members of the Texas Legislature representing this jurisdiction.
